1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
2. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. ### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

### 2. Buyer Added Bid Specific ATC

- 1. Authorized agents/ bidder must submit authority letter from their Manufacturer/Principals Company on the letter head of the manufacturer/principals signed by a competent person. The authorization letter must give/mention the purpose for which it is allowed. The validity period of the authorization letter must be mentioned in the authority letter otherwise tender will be liable to rejection.**
- 2. Bidder/OEM must have experience of Three years or more in supplying and manufacturing similar items or Lab equipment's to customers such as IITs/NITs/Government Engineering Institutes/Technical Universities. Proof must be submitted.**

6. GST return -Last three months shall also be required to be uploaded alongwith bids by the bidders otherwise tender will be liable to rejection.
7. Instruction manuals (hard & soft copy) consisting of experimental procedures should be provided at the time of delivery.
8. Pre Order Demonstration of the offered products can be asked for during Technical Evaluation if required. The bidders have to provide samples at Institutes premises at their own cost within stipulated time as decided by committee from the date of demand. The final technical qualification will depend on the demonstration, quality and specifications of the product. The technical committee will inspect the sample product of the bidder. A bidder will be considered technically qualified only if the technical committee is satisfied with the product offered by that bidder. No request will be entertained if the product is of low quality and does not match the required specifications.
9. Bidder/OEM must have active service center/local service executive in consignee state, details to be submitted on Letter head.
10. The OEM / Bidder must have ISO 9001, ISO 45001 & ISO 14001 Certificate for better evaluation of Bid.
11. GST and PAN of the Bidder to be submitted along with technical bid.
